

**TOWNSHIP OF WANTAGE  
AN ORDINANCE AMENDING ORDINANCE 2008-07**

**ORDINANCE #2008-14**

**WHEREAS**, On August 14, 2008, the Mayor and Committee of the Township of Wantage abolished the Municipal Court of the Township of Wantage and also created the Joint Municipal Court of the Pursuant to the provisions of N.J.S.A. 2B:12-1 et seq. through the adoption of Ordinance 2008-07, and

**WHEREAS**, with the adoption of Ordinance 2008-07. the effective date for abolishing the Municipal Court of the Township of Wantage was set at August 31, 2008 at 11:59PM, and the effective date for the creation of the Joint Municipal Court of the Township of Wantage and the Borough of Sussex was established as being after August 31, 2008, and

**WHEREAS**, the Assignment Judge of Vicinage 10, covering Morris and Sussex Counties, has subsequently recommended that the effective date for the creation of the Joint Municipal Court of the Township of Wantage and the Borough of Sussex as being after September 30, 2008,

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Wantage that Ordinance 2008-07 be and it is hereby amended in part, as follows:

**Section 2.** The court abolishment and this ordinance repeal shall be effective September 30, 2008 at 11:59PM and after due notice is given as set forth in Section 3. All Summonses issuing from the Borough of Sussex shall be processed in the Joint Municipal Court after September 30, 2008.

**Repealer.** All ordinances or parts of ordinances or resolutions inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.

**Severability.** If any provision of this ordinance or the application of this ordinance to any person or circumstances is held invalid, the remainder of this ordinance shall not be affected and shall remain in full force and effect.

**Effective Date.** This Ordinance shall take effect upon adoption of an ordinance by the Borough of Sussex abolishing the Municipal Court of the Borough of Sussex and after publication and passage according to law.
