Mr. Plaza reported the following:

Ray Delbury is opening an ice cream pallor on Route 565 in the Tara Inn building. The building still needs a three compartment sink and a grease trap in the septic. The Tara Inn did not require a grease trap because it only served microwaveable food. Mr. Delbury is planning to open in early spring.

A resident on Skytop Road called to report that she was sitting on her couch barefoot and a mole bit her foot. After biting the foot the mole ran and was caught in a glue trap, because it was not an aggressive attack Mr. Campbell felt it was not necessary to check for rabies.

The water samples for the Sussex Wantage library and the Beemerville firehouse tested negative.

The new winery on Layton Road recently had a wine tasting; Mr. Plaza does not believe he has all the permits. Mr. Plaza will visit the winery and drop off the application for a food handler's license.
