## Mr. Plaza reported the following:

A complaint was received regarding solid waste accumulation at Deckertown Union Cemetery. The complaint was forwarded from the DEP. The debris consisted of miscellaneous grave blankets and flower baskets. The debris is now housed in a new area. The complainant was a fired employee.

Vernon Pediatrics referred a dog bite; it was believed that the victim was also the owner. The County has been unable to reach the victim. The phone number was incorrect and they were unable to verify the address.

Green Valley Farms will be opening an ice cream stand next to the fruit stand. They will sell shakes, cones and dipping ice cream, no soft serve. A new septic has been installed including a grease trap. The water will be sampled three times a year.

The Sussex County Health Department has completed the stream sampling required by the State of NJ.
