MINUTES FOR THE REGULAR MEETING OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF WANTAGE, HELD AT THE WANTAGE TOWNSHIP MUNICIPAL BUILDING, 888 STATE HIGHWAY ROUTE 23, WANTAGE, N.J., ON MARCH 14, 2013

<u>Mayor Ron Bassani</u> called the meeting to order, and requested the Clerk to call the roll. Upon roll call, the following members of the governing body were present: Mayor Bassani, Committeeman DeBoer, and Committeeman Gaechter. The following members were absent: None.

<u>Mayor Bassani</u> stated, "This meeting is being held in compliance with the provisions of the Open Public Meetings Act, Public Laws 1975, Chapter 231. It has been properly noticed and posted to the public, and certified by the Clerk."

FLAG SALUTE

<u>Mayor Bassani</u> invited all persons present to participate in the Pledge of Allegiance to the United States Flag.

DISCUSSION: HIGH POINT REGIONAL HIGH SCHOOL

At this time, the members of the governing body held general discussion with Paul Derin, the President of the Sussex Wantage Board of Education, regarding the anticipated budget and tax impact for 2013 from the High School, and various initiatives and programs being pursued. Mr. Derin was joined by Alice Bressett, Business Administrator; Dr. Terrance Brennan, Acting School Superintendent; and Board members Kyle Vealey and Robert Genetelli.

<u>Mr. DeBoer</u> initiated a discussion on the topic of the Vocational Technical schools curriculum, costs, and impact on public high schools.

<u>Mr. Gaechter</u> initiated a discussion on the anticipated impact that the inclusion of Montague's students into HPRHS will have. Dr. Brennan stated his expectation that everyone will wind up a winner by assimilating Montague's students into the High Point High School. Mr. Derin stated that the phase in would begin in September of 2014.

<u>Mayor Bassani</u> expressed an interest in reviewing areas of cooperation between the Township and the school district, including shared service ventures and grant writing opportunities. Dr. Brennan agreed this would be beneficial to review and consider.

<u>Mayor Bassani</u> complimented the Board on achieving a school budget that would have a zero tax impact on the 2013 taxpayer compared to 2012. Dr. Brennan pointed out that this was done without having to negatively affect any existing programs at the high school.

OLD BUSINESS

Early Voting Bill Opposition

At Mayor Bassani's request, Mr. Doherty offered an update on the status of consideration by the State Legislature on a proposed bill which would create early voting locations within each county.

Mr. Gaechter moved to adopt the following resolution:

A RESOLUTION OPPOSING SENATE BILL S-2364 AND ASSEMBLY BILL A-3553 WHICH PROPOSE TO EXPAND THE OPPORTUNITIES FOR REGISTERED VOTERS TO CAST THEIR BALLOTS AT AN ELECTION WITHIN THE STATE OF NEW JERSEY.

WHEREAS, Senate Bill S-2364 and Assembly Bill A-3553 propose to expand the opportunities for registered voters to cast their ballots at an election within the State of New Jersey; and

WHEREAS, the goal of accommodating voters in pursuit of greater participation in the democratic process is a worthy goal; but

WHEREAS, the said bills as they are currently drafted involve proposals that would increase workloads, add more costs to the election process, and ultimately serve to confuse voters more than it would accommodate their needs; and

WHEREAS, the opportunity for "Early Voting" already exists in the State of New Jersey through the Vote by Mail ballot process.

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Wantage in the County of Sussex does hereby oppose Bill S-2364 and Bill A-3553 for the following reasons:

1. These proposed bills, if adopted into law, will create conflicts with already-existing statutory requirements of the election process as found in NJSA Title 19 and Title 40A.

2. The requirement that various polling places must be kept open throughout the County in excess of 80 hours a week, 7 days a week for two weeks before an election will create additional expense on County Boards of Election, who will be required to staff this said polling place with poll workers who will be required to handle voters that come from several voting districts within numerous municipalities as opposed to a single voting district at each polling place on election day.

3. The Sussex County Board of Elections points out that the average age of Poll workers in Sussex County is 72 years. The Bills would require complete re-training of poll workers on how to handle Early voting Elections; many current poll workers will not be interested or physically capable of staffing polling places for such extended periods of time; hiring new poll workers and training them will be required; costs will be incurred in transporting election materials to and from each early voting location every day in order to maintain chain of custody for protecting the integrity of the ballots cast; overtime costs would be incurred for staffing the Board of Elections offices each day and each evening, all of which adds up to excessive additional expense.

4. These Bills create an excessive conflict creating an unreasonable and unrealistic 80 hour work week for Municipal Clerks who are required, by law, to be in their offices during the hours that polls are open for an election. Additionally, many municipalities now rely on their Public Works employees to set up and take down polling places, which will have to be done 27 times during the course of a year if these bills are adopted into law, compared with the twice a year work load currently in place. This will create overtime issues on municipalities.

5. The use of a municipal building for seven (7) days a week, for two (2) weeks prior to the election, for up to 12 hours a day in order to accommodate the requirements of early voting locations, will create an inherent conflict with already-scheduled court sessions, meetings of governing bodies, meetings of various boards such as Planning Boards, Zoning Boards, Recreation Commissions, and Boards of Health, which will require re-scheduling and postponing hearings on applications before those bodies, in turn creating inconvenience for the general public and increased costs for the municipality.

6. The Bill Sponsors themselves estimate that tens of millions of taxpayer dollars will have to be spent annually if these bills are adopted into law, and it will be done to address a need that does not exist. Current state law allows a voter to download a Vote By Mail Ballot application (or receive one by mail), mail in that application, receive a Vote By Mail ballot, and cast their ballot, without ever having to leave their own home or business location.

BE IT FURTHER RESOLVED, the Township Committee of the Township of Wantage does hereby call upon its representatives in the State Legislature to oppose the adoption of these bills.

AND, BE IT FURTHER RESOLVED, that a copy of this Resolution shall be sent to the Office of the Governor, the Sponsors of Bill S-2364 and Bill A-3553, Senator Stephen Oroho and Assemblywoman Alison McHose and Assemblyman Space, the Sussex County Board of Elections, and the New Jersey League of Municipalities

Douglas Ricker, Beemer Road, reported on a matter of illegal dumping, which he reported to the state police; and offered input from Maxx Span Realtors regarding various auctions they have conducted for municipalities involving farmland that was deed restricted prior to sale. Mayor Bassani and Mr. Ricker spoke briefly regarding the status of the Open Space Committee and efforts to find an agreeable meeting date.
