<u>Mayor DeBoer</u> digressed from the Regular Order of Business at his time to acknowledge the presence of a New Jersey State Trooper who joined the meeting. Mayor DeBoer explained that one outcome of his recent meeting with Sussex Station Barracks Commander Lt. Seaman was for a courtesy presence by a State Trooper when possible, at Wantage public meetings, to promote and preserve a smooth line of communication with the State Police. Mayor DeBoer welcomed the Trooper to the meeting.

# **OPEN PUBLIC SESSION:**

Mayor DeBoer opened the meeting to the public at this time.

William Gettler, Gemmer Road, expressed concern that he was informed that water sampling at Lake Neepaulin was done incorrectly; and expressed concern that signs directing people to St. Clare Hospital in Sussex were misleading;

Mayor DeBoer, Mr. Gaechter, and Mr. Gettler discussed the concern regarding the signs.

Mr. Gettler expressed his disagreement with the joint purchase of a Ladder truck by Wantage and Sussex in 2003. General discussion took place regarding this topic.

Ann Smulewicz, Route 23, offered congratulations to Jon Morris for winning the Election; offered congratulations to the Recreation Commission for the recommendations they presented; stated her belief that members of FOLN should not be included as a subcommittee for recommendations concerning Lake Neepaulin; expressed a desire to have her complaints and concerns regarding her neighbor's impact on her property dealt with by the Township in a comparable manner as the residents' concerns on Lower Unionville road were addressed; expressed disappointment that representatives of Wantage were not present at a recent meeting at the County Administration Building in which the Freeholders received a presentation on population trends and expectations for economic development options in the future.

#### PAGE FIVE OF THE MINUTES OF NOVEMBER 13, 2014

Mayor DeBoer explained that a meeting between State elected officials, county freeholders, and local elected officials was held last week, which Mayor DeBoer and Mr. Doherty attended, at which much of the information Mrs. Smulewicz mentioned was discussed and reviewed, so even though the Mayor did not attend the public meeting, he and Mr. Doherty were in fact debriefed on the topic.

Mrs. Smulewicz and Mayor DeBoer continued to discuss matters involving economic development and the Fire Department and First Aid Squad.

Kathy Gorman, Fernwood Road, expressed thanks to the Recreation Commission for their input on proposed use regulations at Lake Neepaulin; expressed disagreement with a suggestion for creating a subcommittee of the Recreation Commission to offer input on this topic; expressed opposition to the possibility of allowing swimming in the lake; suggested implementing use regulations and recreational programs in increments rather than all at once.

Mr. Bassani clarified that he was not suggesting FOLN should play a role in the decision making process regarding use regulations at the lake, but that it made sense to use whatever experience and information they may have which would be beneficial to the Township. General discussion on this topic continued between Mr. Bassani and Mrs. Gorman.

Mrs. Smulewicz again offered observations on Lake Use Regulations, and again expressed her appreciation for the input from the Recreation Commission.

Mr. Gaechter clarified that no one on the governing body has, in any way, discredited the input from the Recreation Commission. The governing body is simply tabling a decision regarding their input and recommendations pending further review and consideration, so that due diligence can be performed before a decision is made.

<u>Mayor DeBoer</u> stated that no one in the Wantage community has even brought up the topic of swimming or no swimming at the lake to him, but his memory of swimming in lakes as a child are fond ones, and he believes it is prudent to investigate whether it is possible to provide such an opportunity for today's Wantage youth.

No one else expressed a desire to speak. Mayor DeBoer closed the meeting to the public.

# **EXECUTIVE SESSION**

- BE IT FURTHER RESOLVED that Minutes will be kept on file in the municipal clerk's office, and once the matter involving the confidentiality of the above no longer requires that confidentiality, then the minutes shall be made public.
