Introduction of Ordinance

A motion is in order to introduce on first reading Ordinance #2017-12 BOND ORDINANCE PROVIDING FOR THE ACQUISITION OF OPEN SPACE IN AND BY THE TOWNSHIP OF WANTAGE, IN THE COUNTY OF SUSSEX, NEW JERSEY, APPROPRIATING \$950,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$950,000 BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF.
