

PUBLIC NOTICE

**TO RUN FOR THE WANTAGE TOWNSHIP GOVERNING BODY
(The Mayor and Committee of the Township of Wantage):**

IF YOU WISH TO RUN AS A REPUBLICAN, You will need to obtain a petition from the Wantage Township Municipal Clerk, Jim Doherty. In order for your name to appear on the June 4, 2013 Primary Election Ballot, you will need to obtain at least twenty five (25) signatures on the petition (signatures of registered Republican Voters of Wantage Township), and submit the petition to the Office of the Municipal Clerk at 888 Route 23 in Wantage, on or before 4:00 p.m. on April 1, 2013.

IF YOU WISH TO RUN AS A DEMOCRAT, You will need to obtain a petition from the Wantage Township Municipal Clerk, Jim Doherty. In order for your name to appear on the June 4, 2013 Primary Election Ballot, you will need to obtain at least five (5) signatures on the petition (signatures of registered Democratic Voters of Wantage Township), and submit the petition to the Office of the Municipal Clerk at 888 Route 23 in Wantage, on or before 4:00 p.m. on April 1, 2013.

IF YOU WISH TO RUN AS AN INDEPENDENT, You will need to obtain a petition from the Sussex County Clerk. In order for your name to appear on the November 5, 2013 General Election Ballot, you will need to obtain at least one hundred (100) signatures on the petition (signatures of Registered Voters of Wantage Township), and submit the petition to the Office of the Sussex County Clerk in Newton, on or before 4:00 p.m. on Primary Election day, which is June 4, 2013.

**TO RUN FOR THE DEMOCRATIC COUNTY COMMITTEE IN 2013
(Also known as the Democratic Municipal Committee of Wantage):**

You will need to obtain a petition from the Wantage Township Municipal Clerk, Jim Doherty. In order for your name to appear on the June 4, 2013 Primary Election Ballot, you will need to obtain the number of signatures on the petition as shown in the chart below. Signatures on the petition must be by registered Democratic Voters of Wantage Township living within the Voting District of the Candidate. You must submit the petition to the Office of the Municipal Clerk at 888 Route 23 in Wantage, on or before 4:00 p.m. on April 1, 2013. Numbers shown reflect the minimum number of signatures that need to be included on the petition.

Bracketing: If you wish to be bracketed with another candidate, you must circulate and file a Joint Petition. The order in which the candidates' names appear on the joint petition is the order in which the names will appear on the ballot.

Slogans: Permission is required from the Party County Chairperson (Democrat or Republican, depending on your affiliation), if you wish to use one of the official party slogans on your petition and on the ballot.
