GENERAL ORDINANCES OF THE TOWNSHIP OF WANTAGE.**

**ORDINANCE #2009-12**

**BE IT ORDAINED** by the Mayor and Township Committee of the Township of Wantage, that Chapter XXI, the fee chapter of the Wantage Township General Ordinances, is hereby amended as follows:

**Section 1.** Chapter 21, Fees, is amended as follows:

**A.** §21-3, General Fees, is amended as follows:

Public Record Copying Charges, per copy	\$ 0.10
Recording of Public Meeting on CD-Rom, per CD:	\$ 1.00
Clothing Donation Bin, Annual Registration Fee per bin:	\$25.00

**B.** §21-7 POUND FEES, is amended as follows:

Animal Pick-up	\$15.00
Surrender Fee	25.00
Redemption Fee	25.00
Disposal Fee, per lb.	At cost
Redemption Fee	25.00
Adoption Fees:	
Dog of Licensing Age	35.00
Puppy, Mixed Breed	40.00
Puppy, Pure Breed	45.00
Domestic Cat, any age	25.00
Kennel Fees: Dogs or cats	\$7.00 per day
Consignment Fees: Cats	\$20.00
Kittens	10.00
Dogs over 25 pounds	50.00
Dogs under 25 pounds	30.00

**C.** §21-10 PLANNING AND ZONING FEES, is amended as follows:

Final Major Subdivision Application Fee:	\$200 plus \$10 per lot
Concept Meeting, Application Fee:	20.00

**Section 2. Severability.** If any provision of this ordinance or the application of this ordinance to any person or circumstances is held invalid, the remainder of this ordinance shall not be affected and shall remain in full force and effect.

**Section 3. Repealer.** All ordinances or parts of ordinances or resolutions inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.

**Section 4. Effective Date.** This ordinance shall take effect after publication and passage according to law.
