There were two dog bites in January, one at the Wantage Dog Park and another on Eastfield Drive.

A new food plan for Lazer One is being reviewed to serve Soft Serve Ice Cream. Soft serve ice cream requires a state license for dairy.

The Sussex Motel failed a recent water test. The owner placed chlorine in the well, which is not allowed under the revised public water rules, a second test failed because of the chlorine. The well is substandard because of insufficient casing. The State may decide on monthly testing instead of quarterly or possibly drilling a new well to bring the well up to code.
