One of the wells at Wantage Plaza was contaminated with e-coli, since they have two wells they swapped out the well that fed the fire tower to the well that fed the building. The building had been attached to a water tanker the entire time the work on the well was executed.

Mr. Plaza, on a septic inspection at 37 Meadaugh Road noted a spill near an excavator that earlier in the year had been involved in arson. Hazmat was called to clean up the area.
