**ORDINANCE FIXING THE SALARIES OF OFFICERS AND  
EMPLOYEES OF THE TOWNSHIP OF WANTAGE, COUNTY OF  
SUSSEX AND STATE OF NEW JERSEY, FOR THE YEAR 2015**

**BE IT ORDAINED** by the Township Committee of the Township of Wantage, County of Sussex, State of New Jersey as follows:
