Mr. John Nuss of 29 Beemer Road, Wantage NJ, voiced his displeasure and concern regarding the odor located along Route 23 and Cemetery Road. The odor is generated by RER Recycling. Mr. Nuss is concerned the material being composted may contain pesticides that can possibly leach into the groundwater. Complaints to the DEP regarding the odor will only be addressed if the objector is a resident within 500 feet. Mr. Nuss is looking for the support of the Local Board of Health. The Board agreed to send a letter of support to the Governing Body of Wantage, in their efforts to control the odor and expansion of the facility without Township approvals.
