## TOWNSHIP OF WANTAGE ORDINANCE # 04-2024

## ORDINANCE ESTABLISHING SALARY AND WAGE RANGES OF OFFICIALS AND EMPLOYEES OF THE TOWNSHIP OF WANTAGE

BE IT ORDAINED by the Mayor and Committee of the Township of Wantage, County of Sussex, State of New Jersey as follows:

**Section 1:** The salary ranges for hereinafter listed township officers, employees and positions for the year 2024 shall be and are hereby affixed for the year, commencing January 1, 2024 and shall be same until a new ordinance is adopted by the governing body.
